## 2025 PARADE OF HOMES TICKET TERMS OF SERVICE

#### 6. Solicitation

You shall not solicit business from other attendees, exhibitors, or sponsors. Attendees observed soliciting will be ejected from the Event and may be banned from future events at the La Crosse Area Builders Association's sole discretion.

#### 7. Refunds

Tickets are non-refundable. The sale or resale of any and all event tickets by unauthorized means is prohibited and violation of this policy may result in the cancellation of unused tickets. You agree that neither the Homeowners or Builders of the Homes nor the La Crosse Area Builders Association shall be liable for any claims, losses, damages, medical emergencies, sickness, death, injuries, or liability which may be sustained by any person while traveling to or attending the LABA Parade of Homes (including but not limited to) any employee, or any other person or entity. You agree that you will hold harmless and indemnify the La Crosse Area Builders Association from any and all claims, including losses, damages, death, injuries, or liability (including without limitation, reasonable attorney's fees and costs) whether to property, person, or otherwise, that arise while participating in the event. Under no circumstances shall the total liability of the La Crosse Area Builders Association, the Builders, sponsors, or Homeowners for any claim, loss, damage, or cause arising out of or related to this event exceed the price paid for your ticket.

# 9. Force Majeure

If the La Crosse Area Builders Association shall be prevented, in whole or in part, from performing its obligations hereunder due to Act of God, war, national emergency, weather, civil disturbance, pandemic, epidemic, quarantine, labor dispute, governmental or court order or other similar cause beyond such party's reasonable control (a "Force Majeure Event"), then the La Crosse Area Builders Association shall be excused from performance and shall not be considered to be in default with respect to any obligations hereunder.
